Based on review of data presented, it appears that soil with elevated levels of SAR, EC, and/or pH exist below the root zone and are not likely to impact future vegetation establishment given that at least three feet of clean fill material is placed over the affected area. Based on this, COGCC concurs that no further action is necessary at this time, and the remediation numbers and associated Form 27s have been closed (see document numbers above). However, it should be noted that these cases could be re-opened in the future. Should conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards, or, if ground water is found to be significantly impacted, further investigation and/or remediation activities may be required at the sites. Additionally, if re-vegetation is not sufficient to meet COGCC rules, remediation of impacted soils will be required.
