Further to our permitting for the Niobrara Waters Exploratory Well, Swift has established a Water Well Sampling Program following the requirements under COGCC Rule 609. In accordance with Rule 609, Swift has identified 1 well which must be sampled under our Mandatory Sampling Program. Under the Voluntary Sampling Program, Swift has documented 11 wells for sampling. In addition, the Marvel Spring was also sampled as part of the Swift Voluntary Sampling Program.
