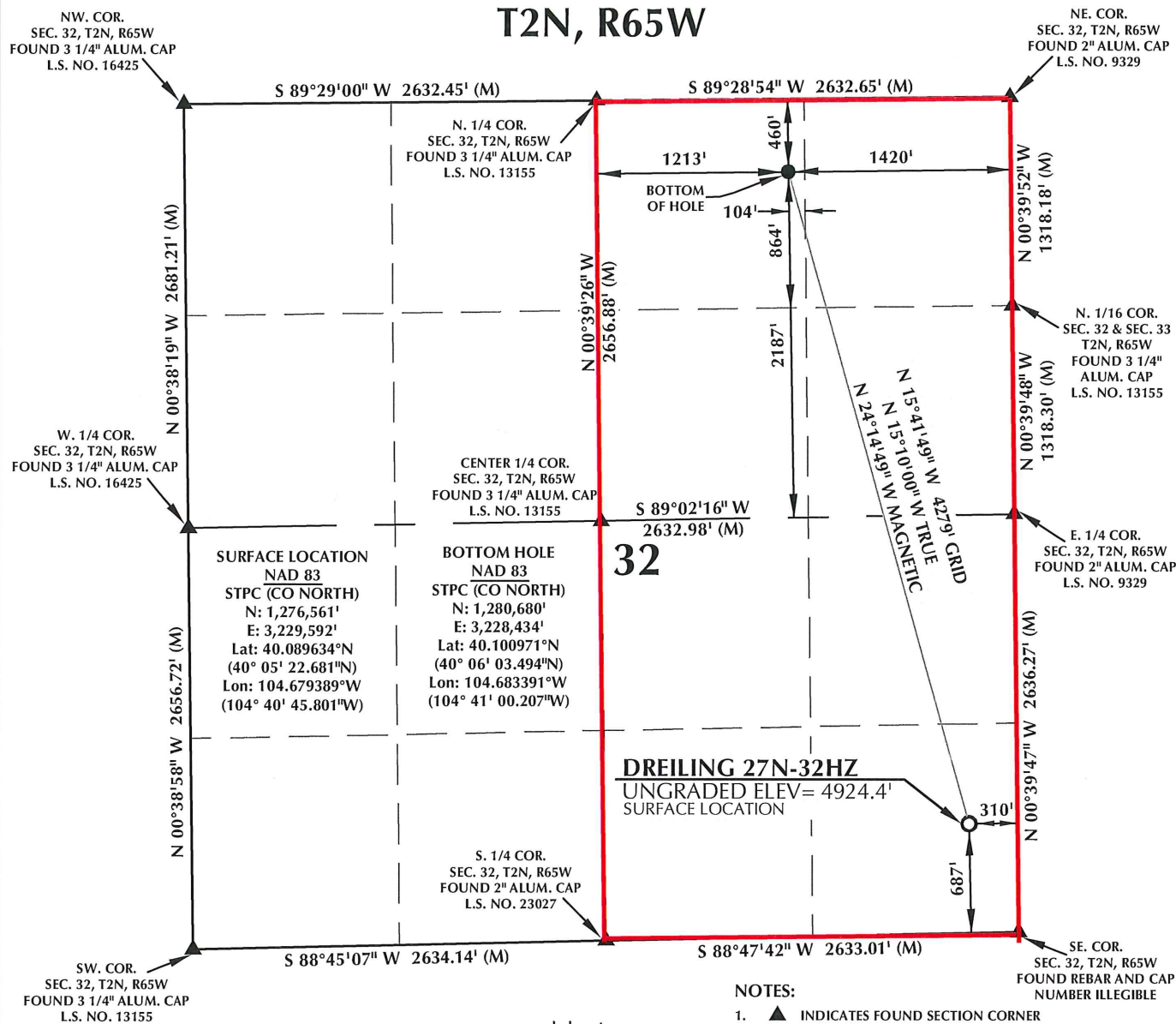

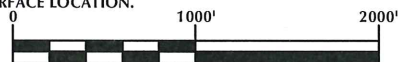
# PROPOSED SPACING UNIT

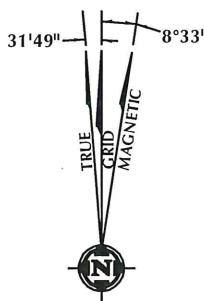
