Julie,

The COGCC is reviewing the above-referenced Form 2A. In order to complete our review process, we request that you address the following items:

1) Per Rule 100, the proposed location is defined as a Sensitive Area because the portion of the proposed location in Section 6 is in the Lost Creek Designated Basin and the Lost Creek Designated Groundwater Management District. With your approval, I will mark the "yes" box for sensitive area on the Form 2A.

2) The current and future land uses are checked as both Crop Land: Dry Land and Non-Crop Land. Only non-crop land is visible on the location photos. Please clarify if crop land is within the planned disturbed area, if not will update the Form at your direction.

3) Because the final land use includes rangeland, a Reference Area map and photos are necessary. The photos may be submitted any time via a Form 4, Sundry, up to 12 months after the Form 2A.
