(a) of the Colorado Oil and Gas Conservation Commission's Rules and Regulations that provides that wells shall be drilled within a square with sides four hundred (400) feet in length, the center of which is the center of any governmental quarter-quarter section ("400' Window"). David F. Kunsemiller hereby consents to the locations Bill Barrett Corporation proposes to drill, complete and operate the following wells:

**Kunsemiller #1** being 300 feet FWL and 1331 feet FNL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is outside of the 400' Window of Subject Lands.

**Kunsemiller #2** being 300 feet FWL and 1311 feet FNL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is outside of the 400' Window of Subject Lands.

**Kunsemiller #3** being 301 feet FWL and 1291 feet FNL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is outside of the 400' Window of Subject Lands.

**Kunsemiller #4** being 301 feet FWL and 1271 feet FNL of Section 21, Township 5 North, Range 61 West, 6<sup>th</sup> P.M., Weld County, Colorado, which surface location is outside of the 400' Window of Subject Lands.

By signing this letter you hereby grant your consent to Bill Barrett Corporation to locate the wells outside of a GWA window as defined by COGCC Rule 318A. (a). Additionally, the wells are being proposed at a surface location which is approximately 3,103 feet from an existing surface well location. By signing this letter you also grant your consent to Bill Barrett Corporation to

locate the wells more than 50 feet from the existing wells as provided for under COGCC Rule 318A.(c).


