Drill cuttings on Berry F01 697 location contain Poly-aromatic hydrocarbons (PAH) (2) and Arsenic concentrations above COGCC Table 910-1 standards. Berry is land-treating cuttings on location to reduce these concentrations below the 910-1 standards. Upon successful remediation indicated by soil sampling lab analyses, cuttings will be buried on location as a precursor to final reclamation. The plan is to complete the landfarming by October 2014. We will submit another sundry once it's completed.
