## COMMENTS:

Drill cuttings on Chevron C20 596 location contain total petroleum hydrocarbons (TPH), SAR, pH, and Arsenic concentrations above COGCC Table 910-1 standards. Berry is land-treating cuttings on location to reduce these concentrations below the 910-1 standards. Upon successful remediation indicated by soil sampling lab analyses, cuttings will be buried on location as a precursor to final reclamation. The plan is to complete the landfarming project by October 2014. Once this has been completed, another sundry will be submitted.
