Drill cuttings on Chevron J20 596 location contain TPH, Poly-aromatic hydrocarbons (PAH) (1) and Arsenic concentrations above COGCC Table 910-1 standards. Berry is land-treating cuttings on location to reduce these concentrations below the 910-1 standards. Upon successful remediation indicated by soil sampling lab analyses, cuttings will be buried on location as a precursor to final reclamation. The plan is to complete the landfarming project by October 2014. Once this has been completed, another Sundry will be submitted.
