COMMENTS:

WPX Energy requests approval to notch out a small portion of the western side of the DOE 1-M-25 pad. The reason for this is that it has been found that a workover rig cannot get in to perform well maintenance on the "A" row of wells (shown on attached plat). The only way to get a workover rig on those wells is to back the rig up over the "B" row which causes safety concerns.

The notched out portion of the pad will not go outside of the previously disturbed area. The dirt from this area will be used to berm around the perimeter of the pad and also make sediment traps. This material will also be used to improve storm water controls around the pad.
