1	Construction	<p>Bonanza Creek Energy Best Management Practices for Installation of Cement Water Vaults at locations Associated with Shallow Groundwater</p> <p>The following procedure describes construction practices for setting a partially buried pre-cast cement water vault on locations characterized as containing shallow depth to groundwater.</p> <ol style="list-style-type: none">1) The excavation will first be lined with 4" of clay or other low permeability soil.2) A 30 mil liner will be installed on top of the low permeability soil. The 30 mil liner will be a contiguous liner which will underlay the entire tank battery.3) The tank battery / water vault liner will be keyed into a galvanized steel containment ring installed surrounding the tank battery.4) Sand bedding will be installed to protect the synthetic liner prior to placing equipment in the containment area.
