**Comments:**

The well was plugged on March 21, 1963 and reclaimed thereafter. Specific reclamation procedures are unknown by current Apache personnel. However, the site is currently occupied by native vegetation. The topography and vegetation across the site blends with the surround area such that there is no evidence of a historic well site visible. The well, any pits, mouse or rat holes and cellars that may have existed have been backfilled; debris removed and the surface has been re-contoured back to natural topography. Aerial orthophotos as far back as 1989 show evidence that the site was re-vegetated with a total percent plant cover matching that of the surrounding area.
