- 117240: No status listed. I spoke with Bill Smith, who bought the property from Richard Beck (to whom the water wells are registered), on August 14, 2013 and he claims that there are no water wells to his knowledge on that property.
- 142510: Listed as permit expired. Owned by Bill Smith.

Water wells outside half mile buffer, but within governmental quarter section that is within half mile buffer:

- 24986: contact information is unavailable for WM Hart
- 164068: A letter was sent via fedex and was left on the back door on 8/7/13 for Jeff Strauss. No phone number is available. No response has been received from the owner.
- 147684: Well has a broken fuse. Attempts were made to replace the fuse but were unsuccessful. Well is considered unsuitable for sampling.
