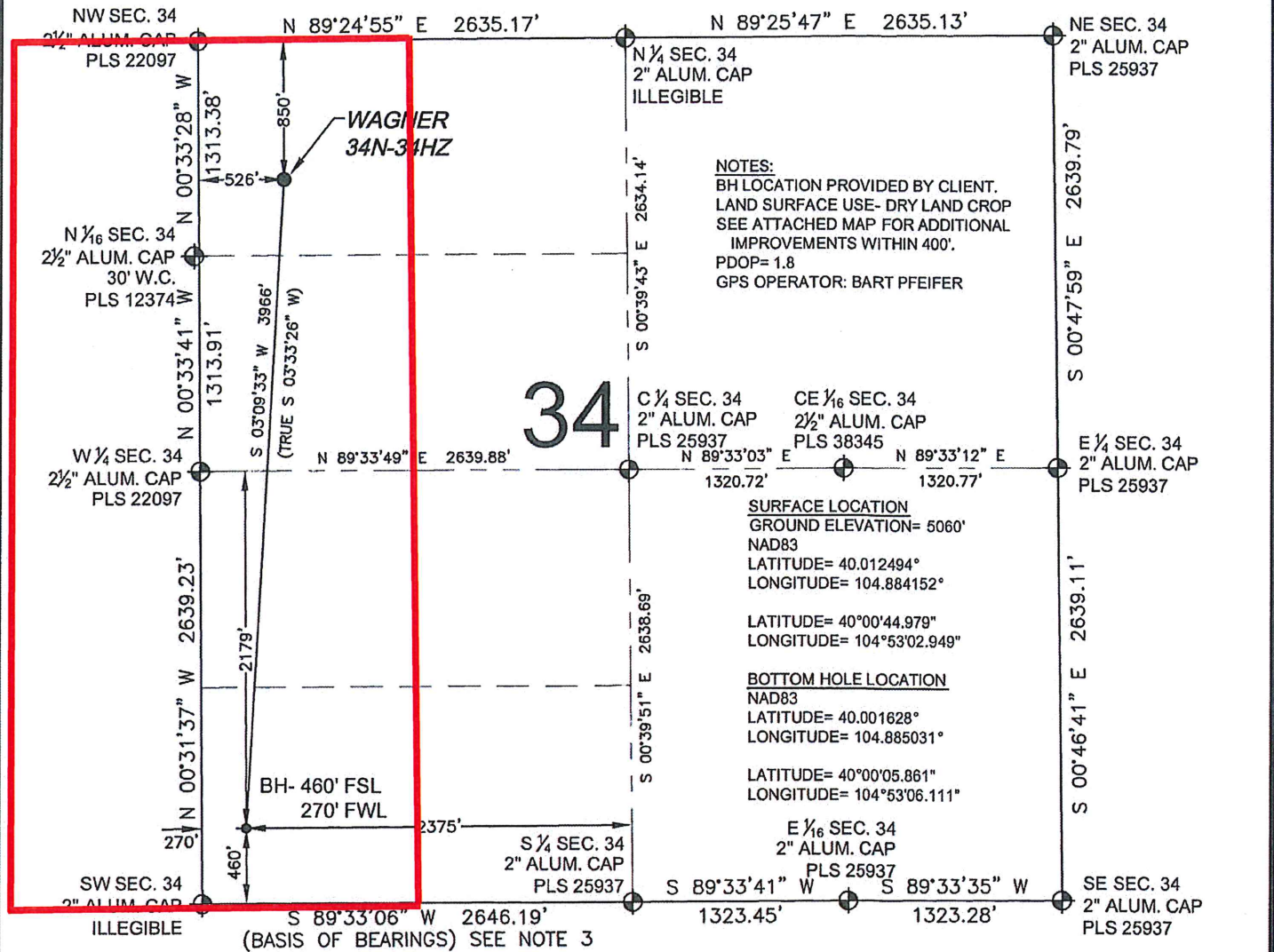

SECTION 34, TOWNSHIP 1 NORTH, RANGE 67 WEST, 6TH P.M.

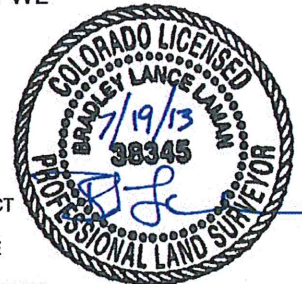


WELL WAGNER 34N-34HZ TO BE LOCATED 850' FNL AND 526' FWL

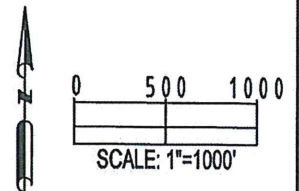
