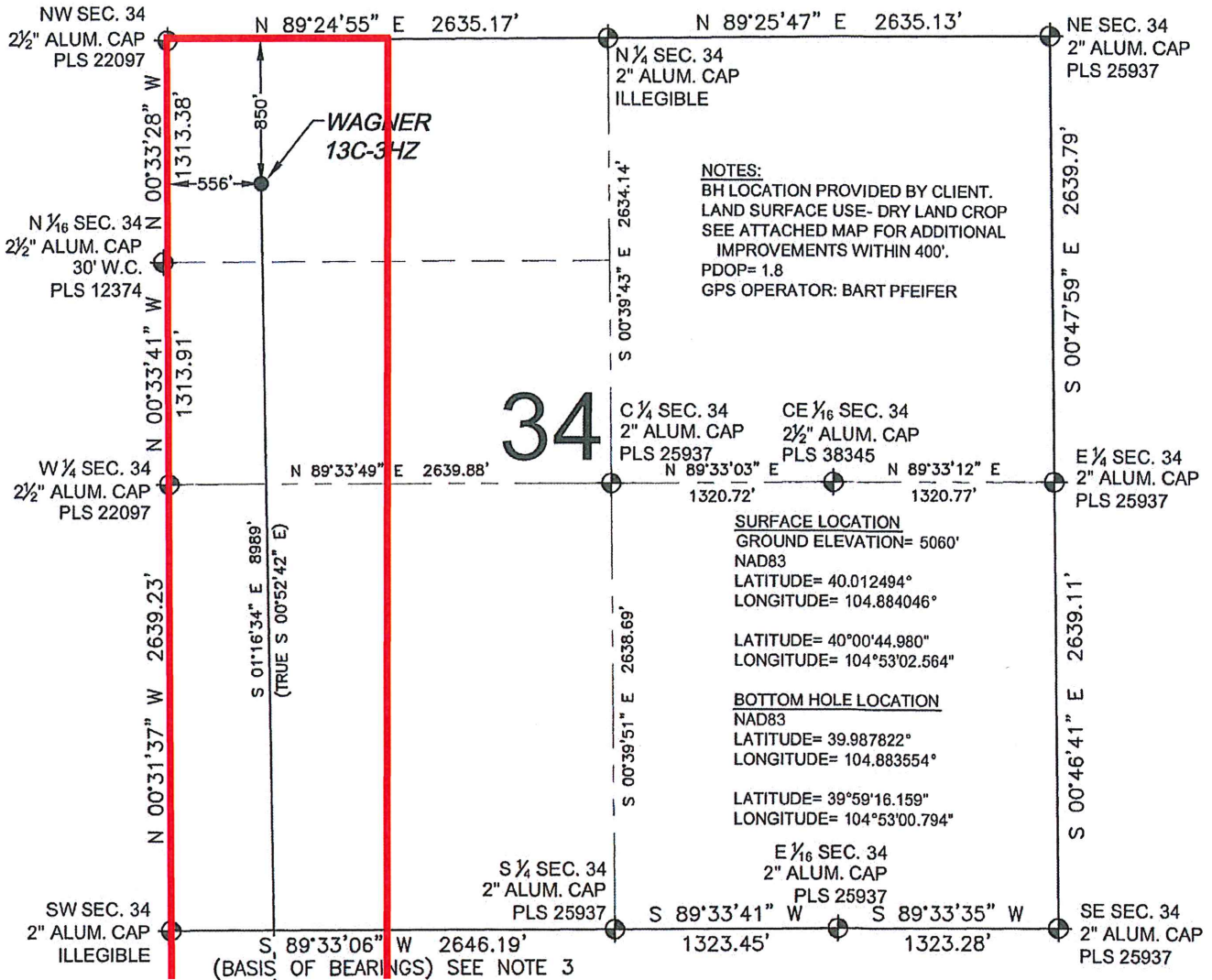

SECTION 34, TOWNSHIP 1 NORTH, RANGE 67 WEST, 6TH P.M.

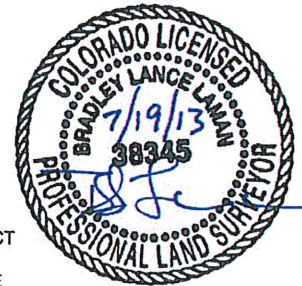


WELL WAGNER 13C-3HZ TO BE LOCATED
 850' FNL AND 556' FWL

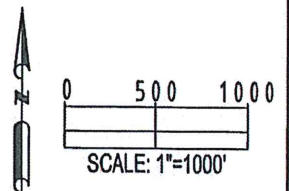

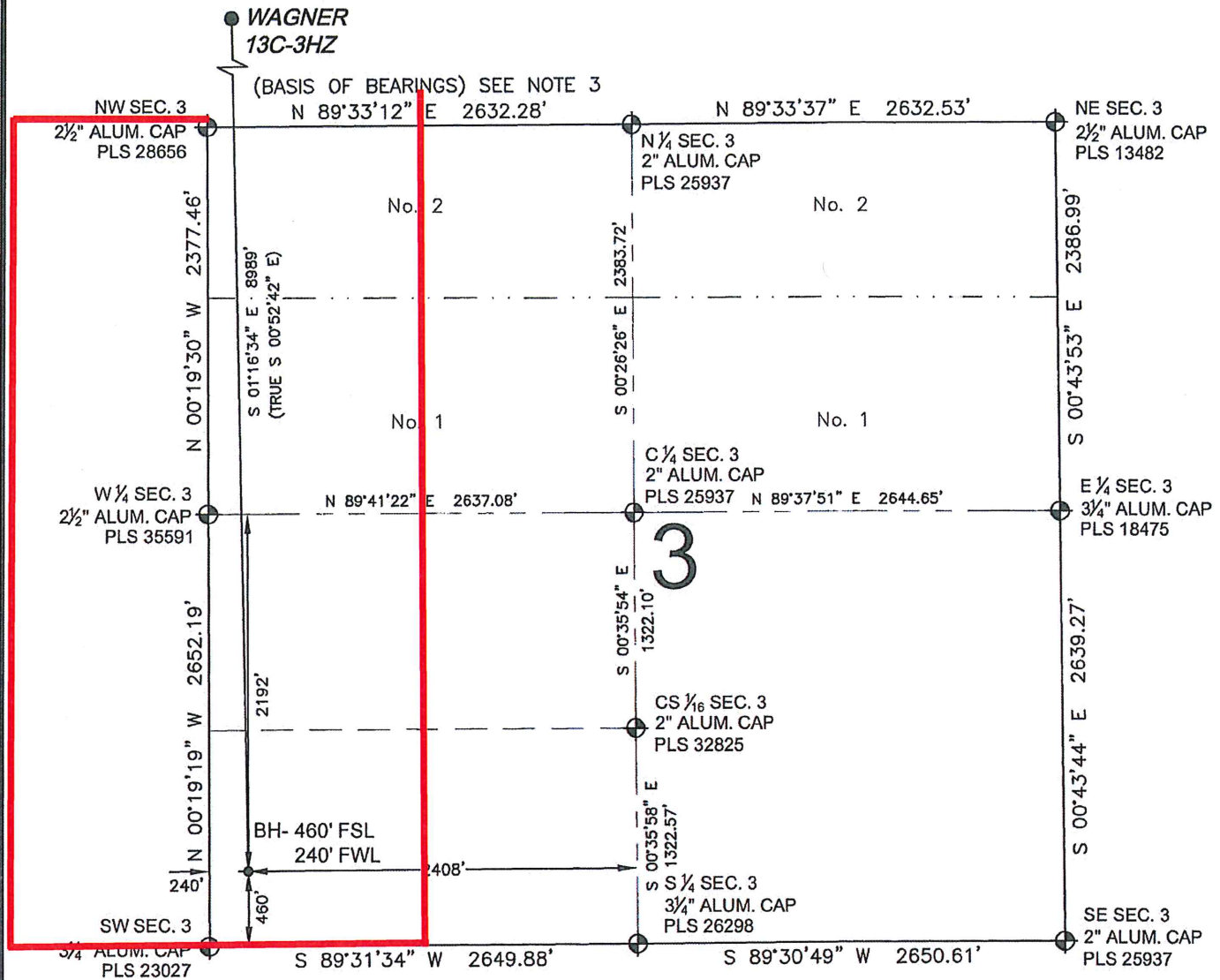

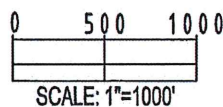
