Due to the adjacent drilling pad, and the proximity of other operations related to the rig and drilling operations, Noble is requesting to increase the pad size by 2 acres for location ID 433076 to a total of 18 acres. The increased acreage will be utilized as a work zone, where welding and other operations can be done at a safe distance from other workers on the pad. The landowner has been notified and has agreed to the additional disturbance.
