## COMMENTS:

OXY USA WTP LP (Oxy) is providing this sundry notice as formal closure documentation of the temporary produced water transfer operations conducted between Oxy and Marathon Oil Company (Marathon). The Oxy and Marathon water transfer agreement was approved by the COGCC on May 13, 2011, reference document number 2523861, of which closure documentation is required. This plan allowed the transfer of produced water from Marathon's 697-21A pad (Location ID 335476) to Oxy's Pond 13 East (Facility ID 414403) and Pond 13 West (Facility ID 414404) locations via transport truck.

No transfer of produced water occurred in 2013. A total of approximately 13,616 bbls of produced water was transferred from Marathon to Oxy between May and June 2012, which was previously reported within the annual transfer summary sundry notice submitted to the COGCC on January 8, 2013.
