Verbal approval to P&A conductors, given by Kevin King on 8/9/2011.

This well was originally permitted by ConocoPhillips Company, the location was built and conductors were set.

Encana Oil & Gas (USA) Inc. acquired this Federal Lease COC65768 and permit back in April 1, 2010.

The Conductors were plugged as described below:  
Step 1: torch the top off of the conductor.  
Step 2: measure the liquid level.  
Step 3: pump water using a submersible water well pump.  
Step 4: fill conductor to bottom of cellar (5 feet below surface) with redi mix.  
Step 5: cut conductors off at bottom of cellar  
Step 6: allow concrete to set and remove cellar rings.

Conductor depth = 110 feet, 19 feet of water pumped off, cemented 5.68 yards redi mix
