#### COMMENTS:

The subject well was scheduled for MIT on 07/11/2013, however MIT was not conducted as scheduled because Chevron has made the decision to Plug and Abandon the inactive well. Chevron is proposing to forgo MIT in 2013 and instead P&A the well as soon as possible in the spring of 2014. P&A is tentatively scheduled for May 1, 2014, or as soon as weather allows access to the Mesa Location. A Form 6, Notice of Intent to Abandon, was filed on 07/31/2013 (Doc #400461362). Last MIT on this well was on 07/11/2008.
