Laura,

I have reviewed the referenced Form 2A and have a few comments.

1) A review of the your Location Drawing appears to indicate that the operational disturbance area will overlap onto the 79 Weld Loam, 1-3% slopes NRCS Soil Map Unit. Therefore I will add that to the Soils section of the Form 2A. Please send me the NRCS Soil Map Unit Description for this soil unit and I will also add it to the list of Attachments.

2) In the Water Resources section of the Form 2A and on your Hydrology Map you have indicated the nearest surface water is an unnamed pond 3,877 feet west of the oil and gas location. However, your Location Drawing indicates there are irrigation ditches 136 feet southeast, 230 feet west, and 894 feet northwest. Therefore I will change the distance to the nearest surface water to 136 feet on the Form 2A.

3) Due to the proximity of irrigation ditches to the oil and gas location, I will change the Sensitive Area designation in the Water Resources section from NO to YES on the Form 2A.

4) A review of the closest water well permit #291339 indicates that 35 feet is the depth of the well and 29 feet is the static water level depth, therefore I will change the depth to ground water in the Water Resources section from 35 feet to 29 feet on the Form 2A.

5) In the Water Resources section of the Form 2A you have indicated that a Rule 901.e Sensitive Area Determination was performed but you have not provided any information concerning it as an Attachment. Please provide me with the Sensitive Area Determination information and results that you have conducted and I will add it to the Form 2A. If a Rule 901.e Sensitive Area Determination was not conducted and this box was erroneously marked as YES, please let me know and I will change it to NO on the Form 2A.

6) Due to the presence of irrigation ditches within the operational disturbance area, I would like to add the following Condition of Approval:
"Operator must implement site-specific best management practices in accordance with good engineering practices, including, but not limited to, construction of a berm or diversion dike, site grading, or other comparable measures, sufficient to protect the irrigation ditches located 136 feet southeast and 230 feet west of the oil and gas location from a release of drilling, completion, produced fluids, and chemical products."
