1. MIRU workover rig. Top kill well in 10 bbl increments with clean 2% KCl.
2. ND WH, NU BOP. POOH with all 2 3/8" tbg landed @6904 ft.
3. RIH with bit scraper and 2 3/8" tbg. Tag TD and clean out to 7026 ft if necessary. POOH.
4. RIH with CIBP and set @ 6540 ft. Dump bail 1-2 sks cmt. TOOH.
5. RIH with CIBP and set @3903 ft (100 ft below targeted Parkman interval). Pressure test csg to 3000 psi.
6. Load hole with fluid and swab well down to 1330 ft (1000 psi underbalanced).
7. Perf under balanced from 3787 ft – 3803 ft, 3639 ft – 3652 ft with 3 1/8" slick gun with 4 spf, 20 gram charges, 0.73" entry holes, 8" penetration, 60 degree phasing.
8. Swab well until oil is seen and flowtest well. Contact Denver Engineering.
