COMMENTS:

At approximately 0300 AM a water leak occurred on a coated 3" carbon lateral line at Emerald 23. Approximately 45 BBLs of brine water and 0 BBLs of oil were released. The line was shut in immediately upon detection. Vacuum trucks removed all of the free fluid; estimated recovery is approximately 28 BBLs of brine water was recovered. The fluids that were picked up were taken to the truck unloading facility at the Main Water Plant for recycling. Water wash of the area has been completed.
