COMMENTS:

At approximately 7:00AM a leak occurred on a 4" cement lined lateral injection line southwest of LN Hagood A-7. The line was shut in immediately upon detection. Approximately 4 BBLs of brine water were released with no oil. The produced water traveled 497 feet into un-named drainage where it was contained by a dirt berm. Vacuum trucks removed all of the free fluid; estimated recovery was approximately 1.4BBLs of brine water.
