Drill cuttings on OM L15 696 location contain Poly-aromatic hydrocarbons (PAH) (5), pH, and Arsenic concentrations above COGCC Table 910-1 standards. Berry is land-treating cuttings on location to reduce these concentrations below the 910-1 standards. Upon successful remediation indicated by soil sampling lab analyses, cuttings will be buried on location as a precursor to final reclamation. The plan is to complete the landfarming project by October 2014. Once this has been completed, another Sundry will be submitted.

Arsenic background samples from nearby native soil (upgradient and cross-gradient of the pad) will be collected to compare arsenic background concentrations with impacted soil arsenic concentrations.
