#### COMMENTS:

ENCANA REQUESTS A VARIANCE TO COGCC RULE 502.B(1), WHICH REQUIRES THE CIBP FOR A MECHANICAL INTEGRITY TEST TO BE SET WITHIN 100' OF THE TOP PERF IN THE WELLBORE. AS REQUIRED BY COGCC RULE 502.B(1), AND AS DISCUSSED BELOW, ENCANA HAS MADE A GOOD FAITH EFFORT TO COMPLY, BUT WE WERE UNABLE TO COMPLY WITH COGCC RULE 502.B(1). WE BELIEVE THAT THIS VARIANCE REQUEST DOES NOT VIOLATE THE BASIC INTENT OF THE OIL AND GAS CONSERVATION ACT.

A 2 7/8" LINER IS CEMENTED IN THE 4 1/2" CASING IN THIS WELL FROM THE SURFACE DOWN TO 4983'. WITH THE RESTRICTED ID WITHIN THE LINER, WE ARE UNABLE TO SET A PLUG IN THE 4 1/2" CASING 100' FEET ABOVE THE TOP PERF IN ORDER TO PERFORM THE MECHANICAL INTEGRITY TEST. WE ARE ABLE TO SET A PLUG AT THE BOTTOM OF OUR LINER AT ~4980'. ENCANA IS REQUESTING THIS VARIANCE IN ORDER TO PERFORM THE MIT FROM THE BOTTOM OF THE LINER AT 4980' TO SURFACE.

GROUNDWATER FROM THE WASATCH AQUIFER IS PROTECTED BY CASING AND GOOD CEMENT BEHIND THE CASING AS SHOWN BY THE CBL, SO NO MIGRATION CAN OCCUR INTO OR ALONG THE WELLBORE.
