Top and bottom measured depths of fish are unknown. Varel 513 bit (1ft length) and discovery 4.75" motor (28.75ft length) were left in hole.</li> <li>v. There are no proposed cement plugs as this is planned as an open hole sidetrack.</li> <li>vi. There will not be any cement pumped.</li> <li>vii.
