OPERATOR COMMENTS AND SUBMITTAL

Comments

Encana needs to sidetrack the Rodman-Bruntz 2E- 26H C266 (API# 051233775900) due to a fish in the hole. We have made two unsuccessful attempts at fishing and are starting to see problems with the Sharron Springs. We reached intermediate TD at 7,835' MD 7,342' TVD and lost the bottom 18' of our mud motor and PDC bit (19' total) The fish is on bottom with the top of the fish at 7,816'. We have 9-58" 40# L-80 surface casing set at 1,262'.

To side track the well we are proposing setting two 400' cement plugs with 5% excess the first one will start on top of the fish (7,816') to 7,416' MD and will be 15.8# class "G" neat (1.15 YLD) and the second plug will start at 7,416' and go to 7,016' MD and be 17.5# class "G" neat (0.94 YLD). We will WOC 12 hours and dress the top plug down to our KOP at 7,070' MD. This well will continue to be a Niobrara well With a new landing target of 7,340' TVD. We will still have the same BHL.

We received verbal aproval from Diana Burns to proceed as proposed on 10/09.
