





In accordance with a request from Michael Cuba with Tekton Energy, LLC Lat40°, Inc. has determined the surface location of the FRYE FARMS 9 #1-5-33-090-4-NH to be 1258' from the SOUTH line and 1173' from the EAST line as measured at right angles from the section lines of Section 32, Township 6 North, Range 67 West and the bottom hole to be 2145' from the SOUTH line and 460' from the EAST line as measured at right angles from the section lines of Section 33, Township 6 North, Range 67 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 11/14/2012, for and on behalf of Tekton Energy, LLC. That this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
