UNPLANNED SIDETRACK - Verbal given by Diana Burn on 10/07/13 at 4:45 P.M.

- i. A geologic fault zone combined with an unknown depth of fish has resulted in the need to sidetrack.
- ii. 8059 ft MD is the total measured depth reached in the wellbore being abandoned.
- iii. 9 5/8" 36# J55 LTC set at 1314 ft MD, 7" 26# P-110 LTC set at 7461ft MD
- iv. Top and bottom measured depths of fish are unknown. Varel 513 bit (1ft length) and discovery 4.75" motor (28.75ft length) were left in hole.
- v. There are no proposed cement plugs as this is planned as an open hole sidetrack.
- vi. There will not be any cement pumped.
- vii. The proposed depth to kick off and side track is 7504ft MD.
- viii. The proposed objective is the same – Niobrara.
- ix. The BHL is the same as the wellbore being abandoned.
