Bottomhole moving to avoid collision issues. There are three offset wells to the west of the lateral that have Clearance Factors less than 1.5 but greater than 1. The HSR Parker 12-15A, the HSR-Schis #5-15A, and the Strear 4-15A. The offset gyro needed to increase the Clearance Factor from above 1 to above 1.5 to the east of the lateral is the Greeley National Bank #1.
