WPX Energy requests authorization to place a permanent pump and building at the Mautz Ranch Multi Well Pit (Location ID#422672) to support our injection operations in the Ryan Gulch area. The structure and pump will be placed on an existing, non-reclaimed portion of the pad and no additional disturbance is expected (see attached site plan). The proposed building will be 100 ft by 20 ft. An automated system will be installed that will incorporate real time data acquisition in order to control, monitor and track pump pressure and volumes. This authorization will be needed for the life of the field and could exceed 30 years.
