Details of work:

Control well w/ 30bbls kill fluid. RIH w/ blade bit, and scraper. Tagged fill at 6334' KB. TIH w/ RBP, retrieved head, 2 3/8" tubing. Set RBP @ 6312' KB. Dump 2 sks sand on top. Pressure test to 1500#. Roll hole. Unland casing. Pick Up mule shoe and TIH w/57 jts of 1 1/4" to 1802'. Test lines to 5000 psi. Pump 5bbl water ahead. Pump 400 sks of "G" neat 15.8 ppg cement from 1748' to 116'. Bond log from 2000' to surface. Reland casing. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Land 2 3/8" 4.7 # J-55 tubing to 6016' KB. Rig down and move off.
