**COMMENTS:**

Vaquero received a notice from COGCC that an MIT must be performed per COGCC Rules 319.b.1 and 319.b.3 for Temporary Abandonment and Rule 326.b.1 for Mechanical Integrity Testing of Shut-In wells. Vaquero Energy received the notice from COGCC that Federal #6-25 was out of compliance in August 2013. Per our contract wiht the landowner, we are unable to access the site from September 1 - November 15 of each year due to owner-operated hunting and guide servce activities. We were unable to schedule and mobilize an MIT between the time of receipt of the letter from COGCC and the beginning of the hunting period designated by the land owner. After November 15th weather will prevent the test from taking place. Therefore we respectfully request a continuance until May 30, 2014 to perform the MIT in order to remain in complaince. By the end of May, we are confident we will have sufficient weather and time to schedule the test, acquire land owner approval, and perform it successfully. If weather and land owner allows, we will perform the MIT at the earliest possible date prior to May 31, 2014. Thank you for your consideration.
