#### COMMENTS:

In response to Inspection Notice Doc 663902223 dated 9/19/2013. Please forward this sundry notice to the attention of Bob Koehler. This well was shut in ~8/1/2011 therefore MIT was due ~7/2013, the decision was made to plug and abandon this well. Form 6 Intent to plug was filed 7/18/2013 and approved 8/12/2013 (see Doc. 400450505). The well was scheduled to be plugged. Due to the winter weather conditions setting in and as requested by the surface/access owner (both Chevron); they do not want Encana to disturb the road and site until late spring 2014, when we can go in and get the plugging and reclamation done all at the same time. The Master Valve on the wellhead is closed on the well to insure the well is closed to the atmosphere. This well is shut in and is currently being reported on the Form 7 as shut in. Future Plan: have the well plugged by 9/30/2014.
