Following the "unplanned sidetrack while drilling: approval and reporting process":

- i. Surveys showed that we were not following the 8.75" cemented hole path perfectly with our 6 1/8" BHA.
- ii. The wellbore was not "plugged back", but rather treated as rat hole. Total MD was 8097ft.
- iii. 9 5/8" 36# J55 LTC casing at 925.74ft and cemented with 350sx of Type-1 cement at 14.2ppg, yield at 1.54cuft/sx, 7.69galwater/sx. 7" 26# HCP-110 LTC casing at 7808ft MD cemented with 565sx lead at 12.7lb, 1.88yld, and 163sx tail at 14.4lb, 1.4yld.
