## COMMENTS:

Kinder Morgan CO2 Company is proposing to install glycol injection equipment on the well location, to address hydrate formation/line obstruction due to freezing, in winter months.

The glycol injection equipment consists of a skid mounted pump and 1,000 gallon glycol storage tank. The pump will inject approximately 100 gallons of glycol per day into the CO2 gas stream. The equipment will be connected to the CO2 production line where it runs above ground out of the well. The injection pump is 24 volt and operated by a solar panel with battery storage. The skid is approximately 10 feet long, 6 feet wide and 15 feet tall, at the top of the solar panel. The custom built skids will be equipped with secondary containment volume of greater than 1,100 gallons (110% of storage volume). The batteries will be contained within a corrosion resistant plastic container, on the skid.

The tanks will be filled by a supply truck every 7 to 10 days, and will be operated between mid-October and June as weather conditions dictate.

When not in operation, the skids will either remain installed on location, or be removed from the well location and stored during the off-season to protect them from potential vandalism as determined necessary by Kinder Morgan.

The pumps are fairly quiet and should not be audible outside of the well pad area.

A plot plan of the glycol skid equipment is attached.

This equipment will be installed at sixteen (16) wells (DC-11, DC-12, DC-13, DC-14, DC-15, DC-18, GP-12, GP-13, GP-14, GP-15, GP-16, GP-19, GP-26, HA-4, HB-6 and HE-6).
