CAUSE INFORMATION: Corrosion in a produces water tranfer line produced a hole in the line, which resulted in release of ~10 barrels of produced water to soil and to a dry manmade drainage ditch that runs beside the access road. This ditch could drain past a culvert to Starkey Creek. However, the ditch was dry, so they could see how far the water went, and it did not reach the culvert. They installed a plug in the culvert so that any drainage would not be able to get past, should it magically get that far. The release was above ground. They will take samples and scrape off the dirt.
