Ted,

I have reviewed the referenced Form 2A Oil & Gas Location Assessment and have a few comments.

1) In the Cultural Distance Information section, you indicate the nearest Building Unit as greater than a mile from the oil and gas location. During my review I identified a Building Unit (a house) approximately 3,600 feet from the oil and gas location. Therefore I will change the distance to the nearest Building Unit on the Form 2A.

2) A review of the Soils section indicates that while you listed the correct NRCS Soil Units for this oil and gas location, the NRCS Map Unit Description attachment on the Form 2A is incorrect (47-Ulm loam). Please send me the correct NRCS Map Unit Descriptions (13-Fort Collins loam and 44-Stoneham Razor complex) and I will attach them to the Form 2A.

3) In the Water Resources section, you have indicated a variance to Rule 609 is requested via a Form 4. I assume because there are no available water sources with 1/2-mile of the proposed oil and gas well as per COGCC Rule 609.c.(1). Per Rule 609.c. you may request an **exception** from Rule 609 by filing a Form 4 Sundry. I will change that statement to reflect this.
