**Operator Comments:**

We are sundrying the locations to correct an error that drilling made when planning the directionals. In most cases, APC permits wells 460' from the section line, and so the drilling group planned the wells to our usual practice. In the case of these wells, however, we planned on spacing in the adjacent section, and therefor intended our heels (7" casing" to land roughly 800' from where it was permitted. We've attached the new drilling plan and template. The errors were discovered when drilling was finalizing their well plans, so one of the sundries is very time sensitive.
