In compliance with the COGCC Conductor Pipe NTO, Ursa is filing this Form 4 Sundry Notice to report conductor set on the CSF 11A-07-07-91 (API 05-045-17085), CSF 21A-07-07-91 (API 05-045-17083), CSF 31A-07-07-91 (API 05-045-17086) and CSF 12A-07-07-91 (API 05-045-11982) the subject Pad. Based on COGCC inspections, all Ursa wells with conductor set have been capped. Ursa is still reviewing all historical well permits for which conductors were set, to determine which are required under Ursa's 2014-2015 Field Development Plan. Once Field Development Plan is set, Ursa will have better information as to which wells will be drilled in 2014 and 2015.
