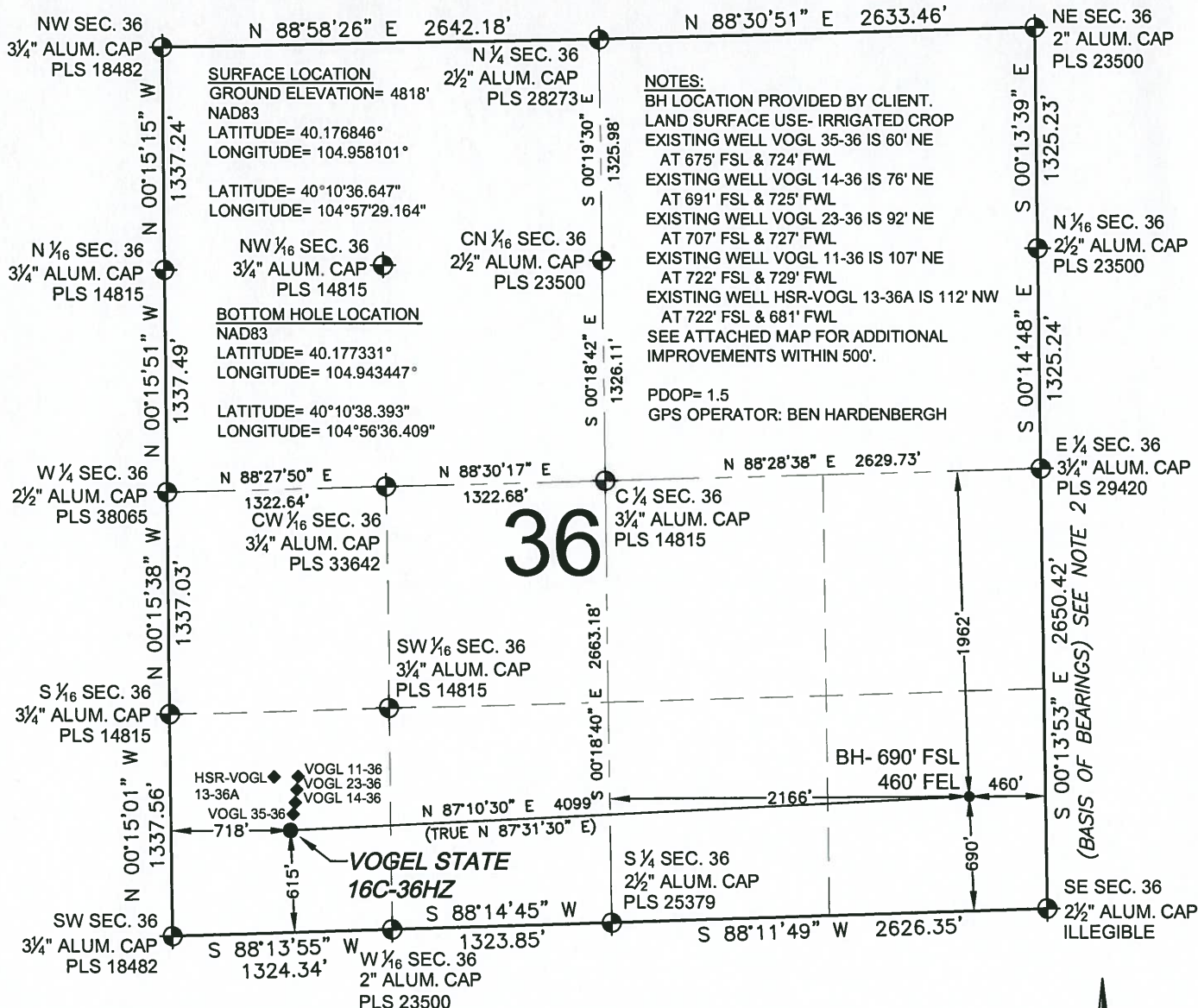


WELL LOCATION CERTIFICATE: VOGEL STATE 16C-36HZ

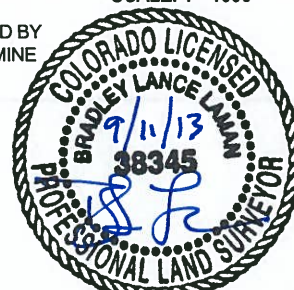
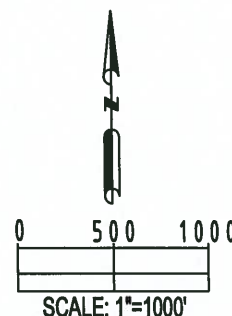
