To Colorado Oil and Gas Conservation Commission:

I would like to file a formal complaint on behalf of myself, my husband Leonard, and my son Dirk. I have spent the past year and a half discussing the damage to our water well with Anadarko but have received no help from them. I understand you assist landowners when oil and gas operations have damaged private property.

We own 80-acres of land. We have two homes on the property, ours at 16423 CR 20, and my son's house at 16307 CR 20.

Around July of 2011, we signed an agreement with Cougar Land Services (who was working for Anadarko) to allow for seismic studies to be conducted on our property. They promised that the only impact to our property would be one hole that they had to drill for the testing.

I told them that they needed to be careful and not harm our water well. In 2000, we spent \$25,000 to have our water well and pump installed that services both homes. Our well produced high-quality water from the Fox Hills aquifer. They came to our property and I showed them the 50-gallon drum that was covering our water well. They promised they would stay at least 200 feet from our well.

On December 30, 2011, seismic trucks came onto our land. Despite their promises, the seismic trucks conducted their tests between my home and our water well! Instead of staying at least 200 feet from our well, they were stopped within 80 feet of the well. I have attached a map that shows approximately where the trucks traveled on our property. The blue X shows the water well and the red line show approximately the route the seismic trucks traveled past our home.

A day or two after they left, muddy water came out of the faucet. The dirt in the water damaged our washing machines, clothes, and our water pressure. We waited two weeks for the water to clear up. At the end of the two weeks, the water cleared up, but it now had a strong odor and foul taste. We called Anadarko and Noble Energy. Eventually they came out and did some tests and told us the water was unsafe to drink.

An entire year later (January of 2013) we received a letter from the COGCC that stated that there were no oil and gas impacts to our water well because oil and gas had not been found in the water. We have never understood why the COGCC tested our water for oil and gas. Our water


well was damaged from seismic testing next to our well. Oil and gas and drilling chemicals would not show up in a well that was destroyed from seismic work.

My husband and I are senior citizens and we cannot pay for installing a new well or even for hauling clean water for drinking and cooking. My husband is in very poor health and he absolutely needs to have clean water to drink.

We also cool our home in the summer with a swamp cooler. As you can see from the attached picture, our old swamp cooler had to be replaced because of the salts and other pollutants in our water. The new cooler gets a build-up of white scale within days. We never had any trouble with our swamp cooler prior to Anadarko coming onto our property.

We believe that anyone who understands the facts will see that we have been harmed by Anadarko's activities on our property. We do not have the financial ability to drill a new well. We are depending on the COGCC to require Anadarko to drill a new well for us, compensate us for hauling our water for the past 16 months, and have them pay for the damage to our appliances.

Blue X depicts water well. Red line is approximate path of seismic trucks.



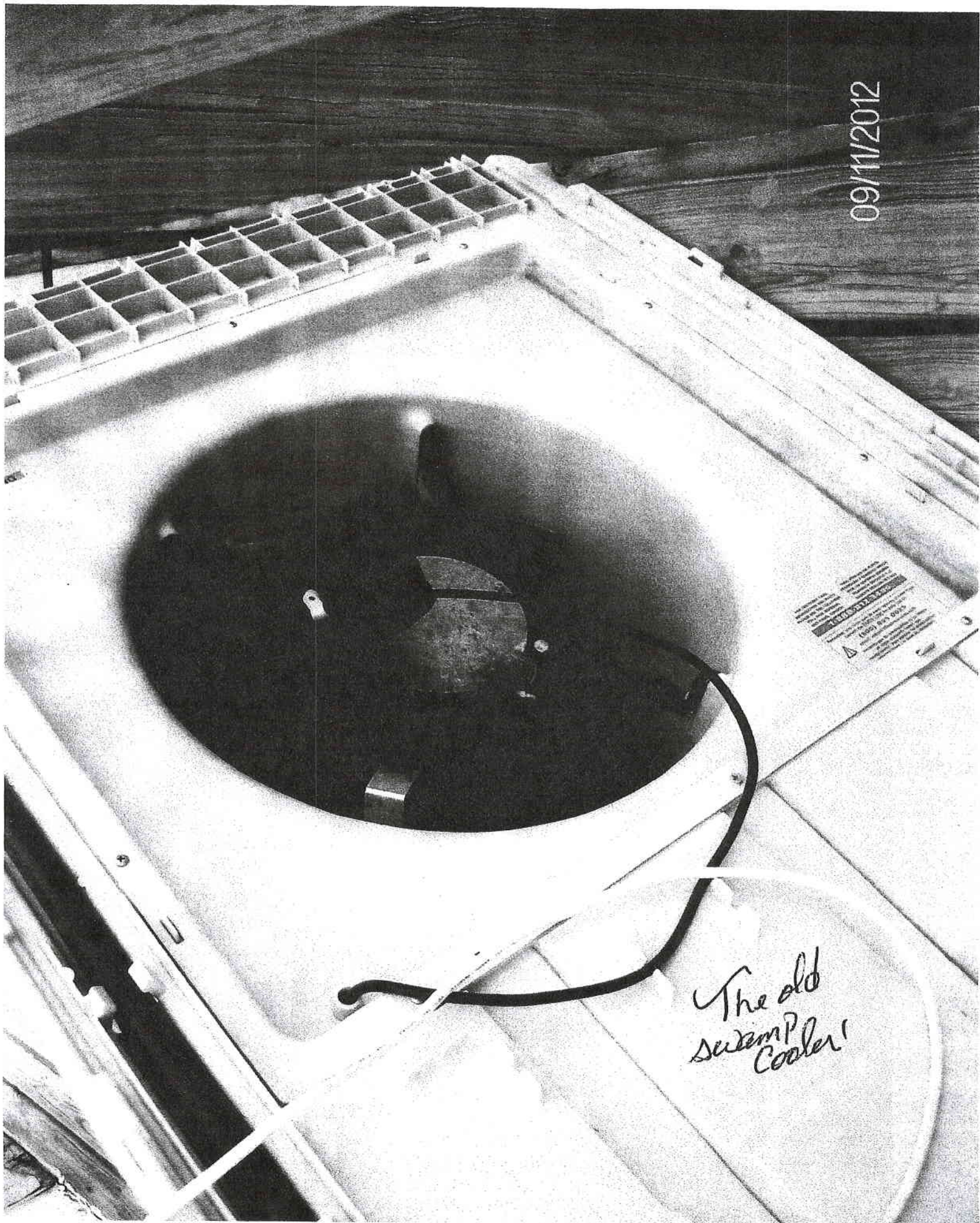
