Cuttings disposal: If the surface owner authorizes, and if it is feasible for this location at the time of drilling, water-based cuttings will be disposed of onsite using bioremediation/solidification product. If current surveys do not exist for the offset wells, Operator may have gyro surveys conducted to verify bottomhole location.
