



In accordance with a request from RANDY EDELEN with BONANZA CREEK ENERGY, INC., King Surveyors has determined the surface location of PRONGHORN 11-41-28HNB to be 1412' from the NORTH line and 370' from the WEST line and the bottom hole to be 647' from the NORTH line and 470' from the EAST line, as measured at right angles, from the section lines of Section 28, Township 5 North, Range 61 West of the Sixth Principal Meridian, County of Weld, State of Colorado.

I hereby state that this Well Location Certificate was prepared by me, or under my direct supervision, that the fieldwork was completed on 10-3-2013, for and on behalf of BONANZA CREEK ENERGY, INC., that this is not a Land Survey Plat or an Improvement Survey Plat, and that it is not to be relied upon for establishment of fence, building, or other future improvement lines.
