#### COMMENTS:

This Sundry is in response to a October 31, 2013 phone conversation between Mark Weems, Coy Bryant, and Andy Antipas. The HD-3 well has elevated annulus pressure that is consistent with the tubing pressure. In addition, there is zero pressure on the bradenhead. Both of these facts supports the conclusion that there is a suspected leak either in the production tubing or packer, not in the production casing. As illustrated in the attached well bore diagram, the well construction consists of chrome production casing and chrome tubing. Many of Kinder Morgan's CO2 wells are tubingless completions. The chrome production casing is utilized because of its corrosion resistance to carbonic acid in the CO2 gas stream, thus protecting the mechanical integrity of the wellbore. Therefore, Kinder Morgan has no plans to work over this well. Kinder Morgan will continue to monitor bradenhead, casing, and tubing pressures on a monthly basis.
