WPXENERGY has reduced the number of proposed wells on this pad from 19 locations to 12 locations. The original disturbed area has been reduced from 5.89 acres to 2.954 acres and the interim reclamation acres has decreased from 1.00 acres to 0.913 acres.

Prior to the current proposed plans, this pad contained 4 existing wells and separators. The number of wells and separators listed in the original 2A has been reduced from 23 to 16. This includes the existing 4 wells plus the proposed 12 locations.
