1	Material Handling and Spill Prevention	Agri-Inject Lubricators: Make sure the Lubricator is on level ground to prevent tipping over; Inspect the plastic hose for cracks and weather wear - for example sun damage, freezing/thawing; Visually inspect the plastic container for holes, cracks, leaks and wear; Visually inspect the copper tubing from lubricator to wellhead for leaks, kinks or wear.
2	Material Handling and Spill Prevention	Stormwater Inspections: Check lubricators for seasonal factors, for example snow cover, snow melt run-off, heavy rains causing run-off - to verify no lubricant is migrating into soil and/or nearby water sources.
3	Material Handling and Spill Prevention	Beam Lubricators: Inspect the Copper Tubing for damage, kinks or wear on tubing; Visually inspect the stainless steel container and Lubricator for holes, dents, leaks and wear; Inspect the plastic hose for cracks and weather wear - for example sun damage, freezing/thawing
4	Material Handling and Spill Prevention	Both types of lubricators: Make sure check valve is close to wellhead to avoid line rupture/failure; Visually inspect the area for soil staining; If soil staining – investigate the cause and report leak to supervisor for immediate repair/replacement and remediation
