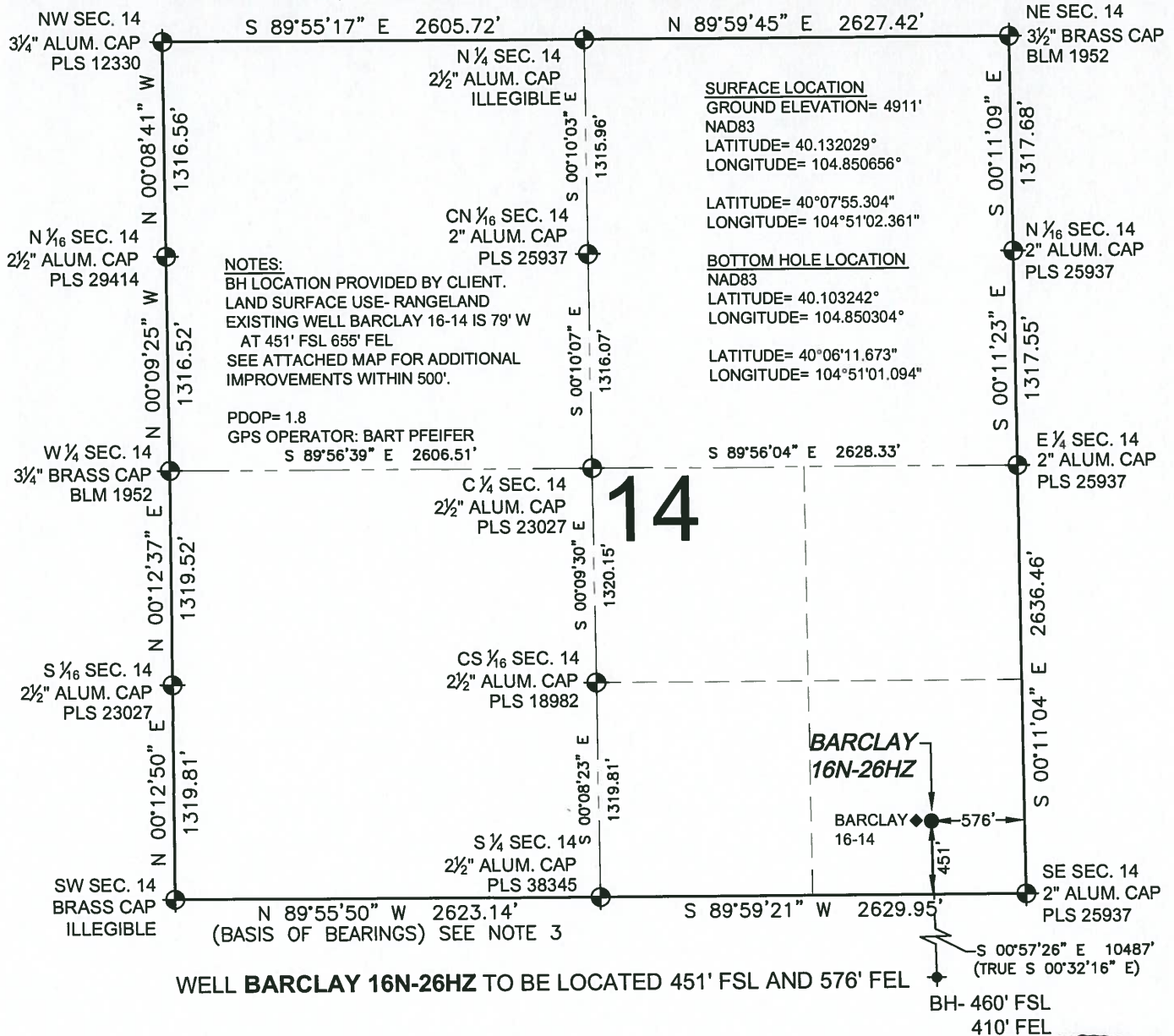


WELL LOCATION CERTIFICATE: BARCLAY 16N-26HZ

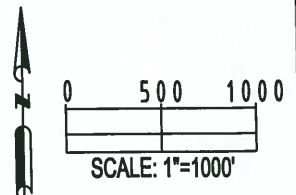

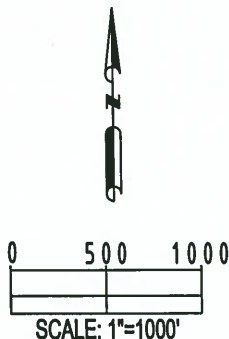

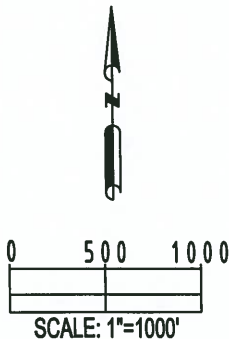
