Comment: This well was visited in reference to a noise complaint. Noise readings were taken with the wind at 7.5 MPH from the NE--the meter was calibrated and showed the following: 61 db 230 ft from the noise source on the east, 64 db 276 ft from the noise source on the south, 57 db 350 ft from the noise source on the west, 64 db 330 ft from the noise source on the north. I also looked up data from the 2A on the Howard 10N-22H wellsite and found that the production from both the Howard 9C-22 Hz wellsite and the Dry Creek 37-27 wellsite was going to be sent down to the battery site serving the Howard 10n-22H wells. This means that they are going to remove the battery currently serving the Dry creek wells--( this will resolve the proximity issue to the complainants business building.)
