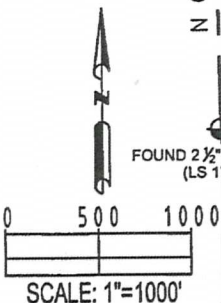
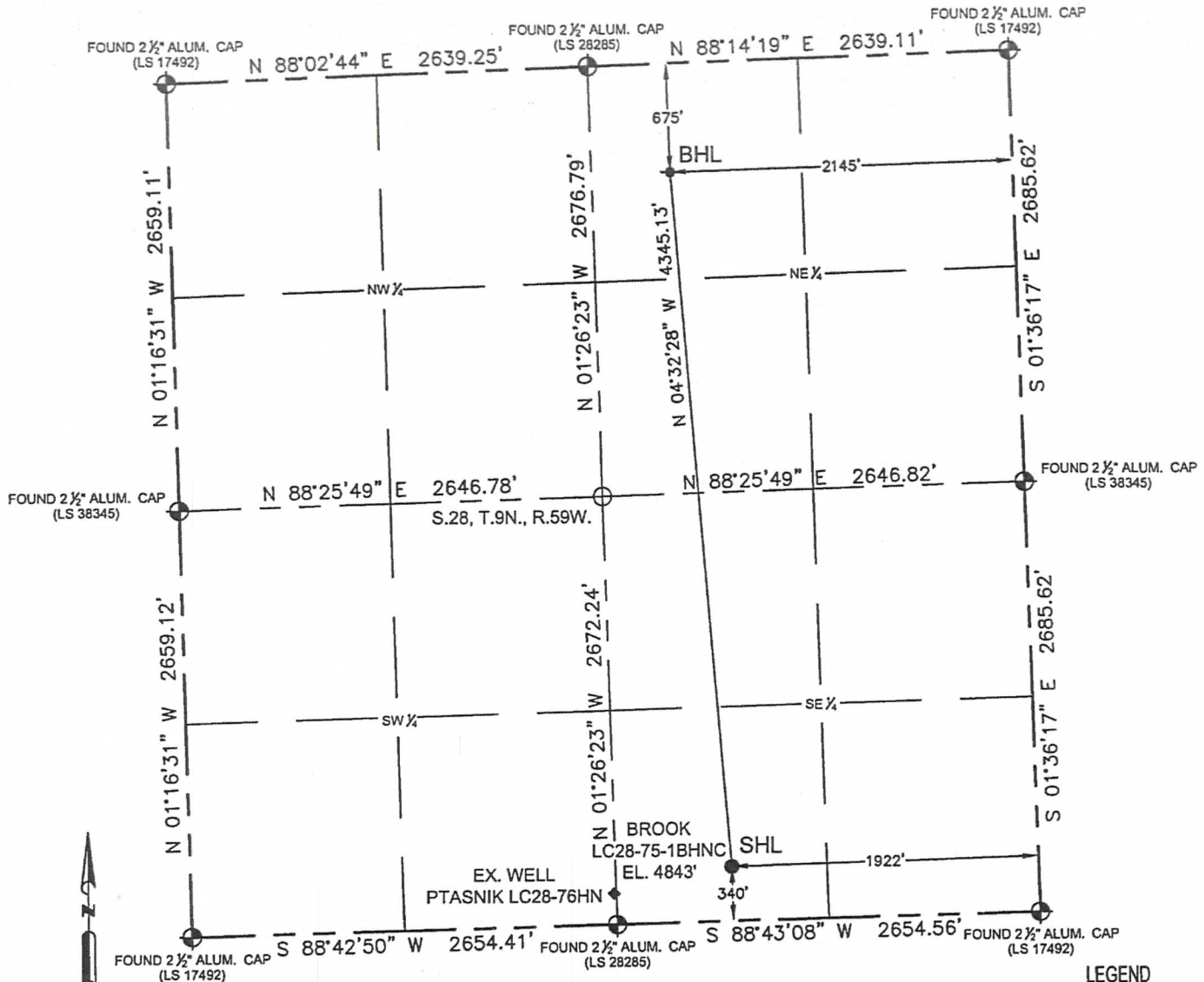


WELL LOCATION CERTIFICATION

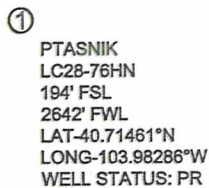

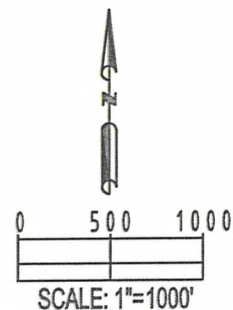
