Details of work:

Control well w/ recycled water. RIH w/ blade bit, and scraper, 220 jts. Tagged fill at 6803' KB. TIH w/ RBP, retrieved head, 205 jts 2 3/8" tubing. Set RBP @ 6373' KB w/ 205 jts. Pressure test to 2000#. Dump 2 sks of sand on plug. Unland casing. Pick Up mule shoe and TIH w/43 jts of 1 1/4" to 1324'. Pump 230 sks of "G" neat 15.8 ppg cement from 1356' to 592'. Bond log from 1580' to surface. Reland casing. RIH w/ retrieving head and establish circulation and latch onto RBP. Roll hole clean and release RBP. Land 2 3/8" 4.7 # J-55 tubing to 6704' KB. Rig down and move off.
